You can easily keep track of your payment by signing up for email notifications about your tax payment Direct Pay.

- Email notification will contain the confirmation number you receive at the end of a payment transaction
- The IRS continues to remind taxpayers to watch out for [email schemes](#). You will only receive an email if you've requested the service

If you have already made a payment through Direct Pay, you can use your confirmation number to access the Payment feature. You can also modify or cancel a scheduled payment until two business days before the due date.

You can also view your payment history by accessing your online account with the IRS.

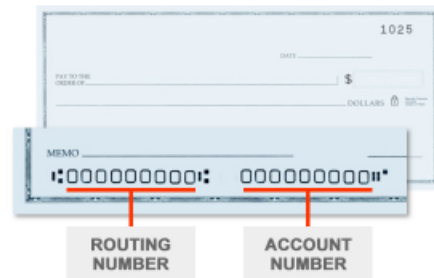
